Dear Mr. Coffey:

This letter is in response to correspondence received on August, 15, 2016 from CTL Engineering of Ohio, which includes the *Phase I History/Architectural Survey for the Greenfield Industrial Park, Madison Township, Highland County, Ohio* (Survey). The Village of Greenfield has applied for the SiteOhio Certification Program (Program), which is administered by the Ohio Development Services Agency. Our comments are made pursuant to Ohio Revised Code (ORC) §149.53; the Survey meets the statutory commitment under ORC §149.53 to cooperate with the Ohio History Connection to complete archaeological and historic survey work during the planning phases on a public improvement.

The Survey recorded twenty-six (26) total architectural resources located within the study area. Seventeen (17) of these resources appear to be fifty years of age or older and none are currently listed in the National Register of Historic Places (NRHP). In addition, the Survey recommended that none of these (17) resources are eligible for listing in the NRHP.

Our office provides the following comments on these Survey results: additional research and evaluation should be considered for resource **AL 14**, the one room school house, which may be potentially eligible for listing in the NRHP. The Survey does not provide enough information to understand how, if at all, the schoolhouse relates within the context of the development of the Village of Greenfield and or its relationship to resource **AL 15**, the farm complex located to the north.

Our office made comments previously, under separate letter, regarding archaeological survey and resources (Serial Numbers: 1063464 and 1064407).

In closing, the Survey fulfills the requirements for history architecture under ORC §149.53. However, please keep in mind for planning purposes that if a future undertaking at the Greenfield Industrial Park has federal assistance (licensing, permitting, funding, etc.), that undertaking will

need to be reviewed by our office in order to comply with Section 106. Section 106 of the National Historic Preservation Act requires federal agencies to take into account the effects of federally assisted undertakings on historic properties.
